

## Cheer Extreme Terms & Conditions

Please initial and sign below:

- I understand that all monthly tuition fees must be drafted. No exceptions. Tuition fees will be drafted on the 1<sup>st</sup> of every month through April 2018. \$35.00 NSF fee charged for returned items.
- I understand that if my bank account information changes, I will notify CEA immediately.
- I understand that there must be a 30 day written notice to leave the program and I understand fees will be drafted until notice is received. Termination notices given to Coaches or Team Moms will not be accepted.
- I understand that all competition fees are NON-REFUNDABLE. These fees will be drafted in payments on the 15<sup>th</sup> of each month until fees are paid in full.
- I understand that if I have an outstanding balance after 30 days, my child will be asked to sit out and a replacement will learn my child's position. I also understand that if I have an outstanding balance after 60 days, my child will be asked to leave the program.
- I understand that no flight purchased for an event will be considered for reimbursement.
- Athletes are only allowed 2 unexcused absences for vacations/school-related commitments. Each absence must be excused at least 1 week ahead of time so that alterations to scheduling may be made if necessary.
- I understand that if my athlete is on a Worlds/Summit team, ALL April 2018 practices are MANDATORY.  
NO EXCEPTIONS
- I understand that Competitive Cheerleading is a team sport and that a practice cannot be taken away from the athlete as a consequence for bad behavior at home at school. Please find a punishment that does not also punish the coaches and teammates or this action is grounds for dismissal from the team.
- I understand that the mandatory skills camp fee is due 2 weeks prior to the summer camp.
- I understand that the coaches have the right to close practices as they deem necessary.
- I understand that if an athlete loses the skills they tried out with, it is the coaches discretion to appoint athlete as an alternate until the skills are performed again.
- I understand if an athlete is injured, a Doctor's note is required for return participation, however, until all required skills can be performed, it is at the coaches discretion to return athlete to the routine.
- I understand that when representing Cheer Extreme at ANY event, ALL athletes will be completely "IN" the uniform (Girls: arms in sleeves of tops, skirts on- Boys: uniform tops AND pants remain on, no flip flops or boots worn with uniforms) or completely "OUT" of the uniform in appropriate street clothes. Athletes will reflect a positive image at all times when representing Cheer Extreme.
- I understand that "Good Sportsmanship" will be practiced at ALL times while representing Cheer Extreme, in person AND on social media. EVERY athlete is expected to be a good ambassador of our program.
