CEA monthly tuition is pro-rated on a 12-month year. **Some months include more instructional hours than others. Vacations and breaks are built into this schedule, as are extra practices and some routine camps. Regardless of the number of instructional hours, the tuition remains the same.** This fee is the price monthly to be a member of Cheer Extreme. Tuition is paid by bank draft on the 1st of every month June thru May and competition fees are paid by bank draft on the 15th of each month, June through March. Tuition and competition fees are drafted for the 30-day period following a written request to leave the program.

Cheer Extreme must be your extra-curricular priority. This is a team sport dependent on the 100% participation of all athletes. Your practices and competitions are mandatory. All events must be attended by all members. Parents can and are encouraged to travel with athletes on trips. Hotel arrangements are made in blocks but rooms are booked on an individual basis. It is your responsibility to book your hotel room for each event before the deadlines given. Money for uniforms will be due the day of fitting. Cash, money order, or cashier's check will be the only methods of payment accepted. NOTE: If you leave the program after you have been sized for a uniform, you will be refunded your payment minus a \$75 restocking fee at the end of our season IF and only IF your uniform is sold; you will not be given your uniform to sell.

- Registration fee is non-refundable.
- Competition fees are non-refundable.
- **In order to be placed on a team roster, registration fee and May tuition must be paid.**

Financial Terms	
	I understand that all monthly tuition fees must be drafted from my checking account. No exceptions. Tuition fees will be drafted on the 1 st of every month through May 2025. \$40 fee charged for all NSF or returned items.
	I understand that if my bank account information changes, I will notify CEA immediately.
	I understand that there must be a 30-day <u>written</u> notice to leave the program and I understand that I will be drafted any scheduled fees for the 30-day period. Termination notices given to coaches or team moms will not be accepted. It must be emailed to ceakimb@yahoo.com
	I understand that all competition fees are non-refundable . These fees will be drafted in payments on the 15 th of each month until fees are paid in full.
	I understand that if I have an outstanding balance after 30-days, my child will be asked to sit out and a replacement will learn my child's position. I also understand that if I have an outstanding balance after 60-days, my child will be asked to leave the program.
	I understand that no flight purchased or travel arrangements for an event will be considered for reimbursement.
	I understand that mandatory skills camp fee is due 2-weeks prior to the summer camp.

Attendance Terms	
	I understand that competitive cheerleading is a team sport and that practice cannot be taken away from the athlete as a consequence for bad behavior at home or at school. Athletes should be able to handle schoolwork and practices. Homework load is not an acceptable excuse for missing practice.
	Athletes are allowed on 2 unexcused absences for vacation/school-related commitments. Each absence must be excused at least 1-week in advance so that alternations to scheduling may be made if necessary.
	I understand that practices may be changed or added at any time during the season.
	I understand that if my athlete is on a team competing at Worlds or Summit, all practices in March, April and May are mandatory. This includes during Spring Break.
	I understand if an athlete is injured, a doctor's note is required for return participation, however, until all required skills can be performed, it is at the coach's discretion to return to the routine.

General Terms	
	I understand that threatening to quit or pull a child from a team will be grounds for immediate dismissal from the program.
	I understand that only cheerleaders and coaches are allowed in the gym - including during private lessons, tumbling classes or practices.
	I understand that athletes who are placed on a Worlds team and then leave the program will not be given a USASF release form to attend Worlds with another program.
	I understand that the coaches reserve the right to close practices at any time for any reason. In this event, the team mom will remain with the team.
	I understand that if an athlete loses the skills they tried out with, it is the coach's discretion to appoint the athlete as an alternate until the skills are performed again.
	I understand that no spots are guaranteed on any team and athletes may be moved if not able to perform required skills for a specific team.
	I understand that good sportsmanship will be practiced at all times while representing CEA, in person and on social media. Every athlete and parent are expected to exhibit good conduct and to be a positive ambassador of our program every day.
	The use of the CEA logo or X-Man logo is copyrighted by Cheer Extreme and cannot be used at any time without the express permission of Betsy Smith and/or Courtney Pope.
	All team apparel must be approved by Betsy Smith and/or Courtney Pope. Parents are not allowed to 'donate' items to the team that use the CEA logo or team name.
	All athletes must be in full uniform or practice wear as instructed by coach or team mom during practice or competitions. This includes correct make-up and lipstick. No 'posh ponies' (or other brands) may be used. Neat appearance is a requirement. This includes during awards ceremonies.
	No athlete releases will be given after January 15 for Worlds teams or March 1 for Summit teams.

Code of Conduct

*Applies to Athletes and Parents

- If you have any questions or concerns that need immediate attention, please use the following chain of command:
1. Team Parent 2. Gym Director 3 Head Coach 4. Owner
- Cheer Extreme maintains the right to refuse services at any time.
- Good sportsmanship, polite manners and good disposition are mandatory at practices, classes and competitions.
- It is the athlete's responsibility to wear the correct practice wear to every practice.
- Personal items such as cell phones, school bags, or gym bags must be stored in the proper place during practice. All cell phones must be turned off before practice starts. Cell phones left lying around the gym floor will be removed from the gym. CEA is not responsible for lost or stolen items.
- NO GOSSIP about any other teams (all star or school). NO GOSSIP about a child on your team or another team. No GOSSIP about coaches or staff. It is much better to address a problem than to listen to idle gossip.
- NO PROFANITY
- Athletes must arrive at all practice, competitions or any scheduled events on time. Punctuality is a must.
- During practices, please keep your opinion to yourself. All team and routine decisions are left to the discretion of the coaches.
- Please feel free to talk to your coach about anything; remember to do so at the appropriate time. Never interrupt practice to have a conversation.
- NEVER post any negative comments on social media.
- No one is allowed to yell onto the floor or try to make contact through the parent viewing area during practice or tumbling classes.
- It is the parent's responsibility to know what is going on with your child's team. Team GroupMe and Gym/Team Facebook pages will be used for updates and last minute changes especially on competition days. Email or Text messaging may also be used.
- Parents, relatives, friends or cheerleaders are never allowed to speak with competition officials for any reason.
- Parents are never allowed to represent Cheer Extreme under any circumstances concerning accommodation, competitions or other situations.
- There will be no arguing or questioning of the coaching staff's decisions at competitions.
- Anonymous emails/ letters/texts, etc will be ignored.
- The Gym Director/ Owners may change, add, or subtract any rule at any time.
- No athlete releases will be signed after January 15 for Worlds teams or March 1 for Summit teams.

1. Gymnastics and cheerleading are vigorous sporting activities involving height and rotation in a unique environment and, as such, pose a significant risk of injury. Gymnastics/ cheerleading and related activities always involve certain risks, including, but not limited to death, serious neck and spinal injuries and serious injury to bones, joints and muscles. The risk of such harm may be limited by safety equipment and coaches, but will never be eliminated;
2. For myself, spouse and My Child, I knowingly and freely assume all such risks, both known and unknown, and even if arising from negligence of Cheer Extreme or others, and assume full responsibility for My Child's participation;
3. I willingly agree to comply with Cheer Extreme's standards and customary terms and conditions for participation in Cheer Extreme programs. If I observe any unusual and significant concern in My Child's readiness for participation and/ or in the Cheer Extreme program itself, I will remove My Child from participation and bring such issue to the attention of the nearest Cheer Extreme personnel immediately.

REGISTRATION FEE:

\$75 for one child - \$100 max per family. (payable cash at try-outs)

Athletes who tried out at Salem location- \$40 individual/ \$60 family

****Registration fee, May tuition and draft paperwork must be completed in order for an athlete to be placed on a team.***

UNIFORMS:

Payment for uniforms will be due at fitting. Cash, Money Order, and Cashier's Check will be the only method of payment accepted. NO PERSONAL CHECKS. Estimated cost of uniform is \$400-450. Uniform for teams using a specialty uniform (Elite or Worlds team) Estimated cost is \$425-500. If you cannot make it to or miss the fittings, you will be required to attend a fitting at another location.

Note: If you leave the program after you have been sized for a uniform, you will be refunded your payment minus a \$75 restocking fee at the end of our season, if and only if the uniform has been sold to another athlete. You will not be given the uniform to sell.

TEAM/COMPETITION FEES: (non-refundable)

Please plan ahead financially to meet the deadlines for the 8 Installments listed below.

- 1) All competition fees: 6-9 competitions per season. Prices vary by team
 - 2) Music fee: \$250 per athlete
 - 3) Coaches Travel Fee: \$250-300 per athlete. Varies by team
 - 4) Choreography Fee: \$125-175 per athlete
 - 5) End of year banquet: \$20 per athlete
- All of the above totaled and divided into 8 installments

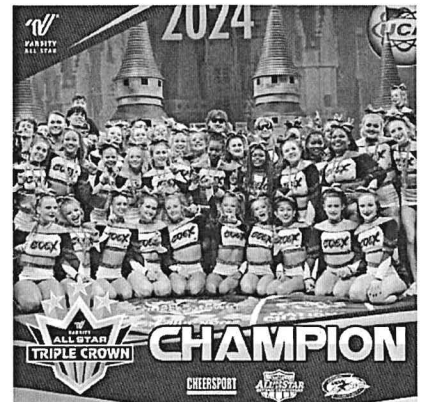
Competition fees @ \$350 /month starting in July and will be reevaluated at the end of September once the competition schedule has been finalized.

*****Crossover athletes will pay a one time fee of \$300 for 1st crossover team; \$150 for 2nd crossover team***

If crossing to another gym and travel to a competition that is not in your home gym competition schedule, you will be responsible for paying that competition fee.
